- 2. TO APPROVE THE MINUTES OF THE PLANNING MEETING HELD ON 27<sup>th</sup> SEPTEMBER 2017 Mrs Vaughan proposed the minutes were a true record of the meeting, Mr Jeanes seconded the proposal, which was passed.
